### Partners

To achieve this high level commitment, partnerships will be forged with government, other UN agencies, the private sector, civil society organizations and the donor community.

The Canadian Government has committed 15 million Canadian dollars in support of a UNFPA-UNICEF Joint project to empower adolescent girls through improved access to comprehensive sexuality education and rights-based, gender-responsive and quality sexual reproductive health services in Ghana

### Preliminary results

- Baseline CYP was set for 2017 at 49,019 CYP for sexually active adolescents and youth 15-24 years based on the Comprehensive Programme Evaluation conducted in 2016
- According to the Strategic Information System record for 2018, There were 51,019 CYP for sexually active adolescents and youth 15-24 years (obtained through MSI impact 2 tool modeling)
- The services provided in 2018 averted an estimated 16,293 unintended pregnancies, 5,857 unsafe abortions, and 37 maternal deaths
- The services provided in 2018 saved GBP 552,737 in costs to families and health care systems on pregnancy related care (ANC as antenatal care and PAC as postabortion care)

#### Definition

'Unintended pregnancies averted' refers to the number of unwanted or mistimed pregnancies that would occur if contraception is not used or effective contraceptive methods are incorrectly or inconsistently used. 'Unintended pregnancies averted' are obtained using the MSI Impact calculator tool.

Couple Years of Protection (CYPs) is a measure that estimates the protection from pregnancy provided by contraceptive methods during a one-year period.

### Theory of change (TOC)

#### The issues

Teenage pregnancy and motherhood remained stagnant from 14.2% in 2014 (DHS 2014) to 14.4% in 2017 (MHS 2017) - largely due to the high pregnancy and childbearing among the 19 years olds (32.3% had begun child bearing by age 19)

Although Contraceptive use among adolescent girls 15-19 years increased from 16.7% (DHS 2014) to 23.8% (MHS 2017), usage is still low (Among females 15-19 years, only 23.8 % used a modern family planning method - MHS 2017)

Ghana UPR reports (2014) raised concerns over a) the high maternal mortality ratios owing in part to teenage pregnancies and lack of access to health-care services;b) the lack of comprehensive education on sexual and reproductive health and rights, including on responsible sexual behavior, and of family planning services

### Interventions

Advocate for and build capacity of duty bearers to enable community actions that will facilitate girls access to SRH information (in particular CSE) and services

Empower Adolescent girls to make informed choices on Sexual and Reproductive Health and Rights issues

Provide modern contraceptive methods to sexually active youth and adolescents 15-24 years through UNFPA supported health facilities and distribution networks

### Assumption

A comprehensive structure and system based on a "Three point access model" (community assets, the Education system, and the Health system) will be elaborated, functionalized and sustained by partners to provide a substructure for the execution of the Project

Partners will support a robust data generation and management system to support evidence-based programming

There will be sustainable financing for adolescent and youth friendly programmes through the national health insurance scheme as part of domestic financing

Government and partners will support distribution of contraceptives to the last mile
